AFFIDAVIT



I, Hutiyu Sokat Ali Adum, Aged 59 Years, Occupation Farmer, Residing at Parnali, Taluka Anklesvar, District Bhavnagar own and possess individually/collectively land bearing block/survey no. \_\_\_\_\_, Old Survey No. \_\_\_\_\_, admeasuring about \_\_\_\_\_ Sq. Meters/Sq. Yards, situated within revenue limits of Village Parnali, Taluka Anklesvar District Bhavnagar on solemn affirmation declare that my land is being acquired by the Government of Gujarat for the establishment of Mumbai-Ahmedabad High Speed Rail Project to be implemented by the National HighSpeed Rail Corporation Limited.

My land is being acquired without my oral or written consent and in absence of any consultation and without offering any sufficient and adequate rehabilitation and resettlement package and infrastructure amenities as envisaged in the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. I am opposed to the acquisition of my land because contrary to the Guidelines for Confirmation of Environmental and Social Considerations of Japan Bank of International Cooperation/ JICA, the State of Gujarat has by way of an amendment to the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 [Central Law], has diluted the provision with regard to prior informed consent of affected landowners, provision/s with regard to rehabilitation and resettlement package and provisions with regard to social impact assessment. Moreover, even a notice, declaring intention of acquisition for the project in question has been issued by the State of Gujarat without revising and upgrading the market value of the lands, contrary to the existing provision of law which will deprive the land owners of sufficient and adequate compensation based on existing market value.

I further declare that I do not want my land to be acquired and do not want the bullet train [Mumbai Ahmedabad High Speed Rail] Project and with the present declaration I express my complete opposition to the project of bullet train.

I state and submit that I am swearing the present declaration on my own volition and without any influence whatsoever.
